### **Road Closure and Removal of Highway Dedication Bylaw** **Haug Road Adjacent to 3957 Lakeshore Road**

**A bylaw pursuant to Section 40 of the Community Charter  
to authorize the City to permanently close and remove the  
highway dedication of a portion of highway on Haug Road**

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. That portion of highway attached as Schedule "A" comprising 245.3 m<sup>2</sup> shown in bold black as Closed Road on the Reference Plan prepared by Douglas A. Goddard B.C.L.S. and completed on 21st day of July, 2004, is hereby stopped up and closed to traffic and the highway dedication removed.
2. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.

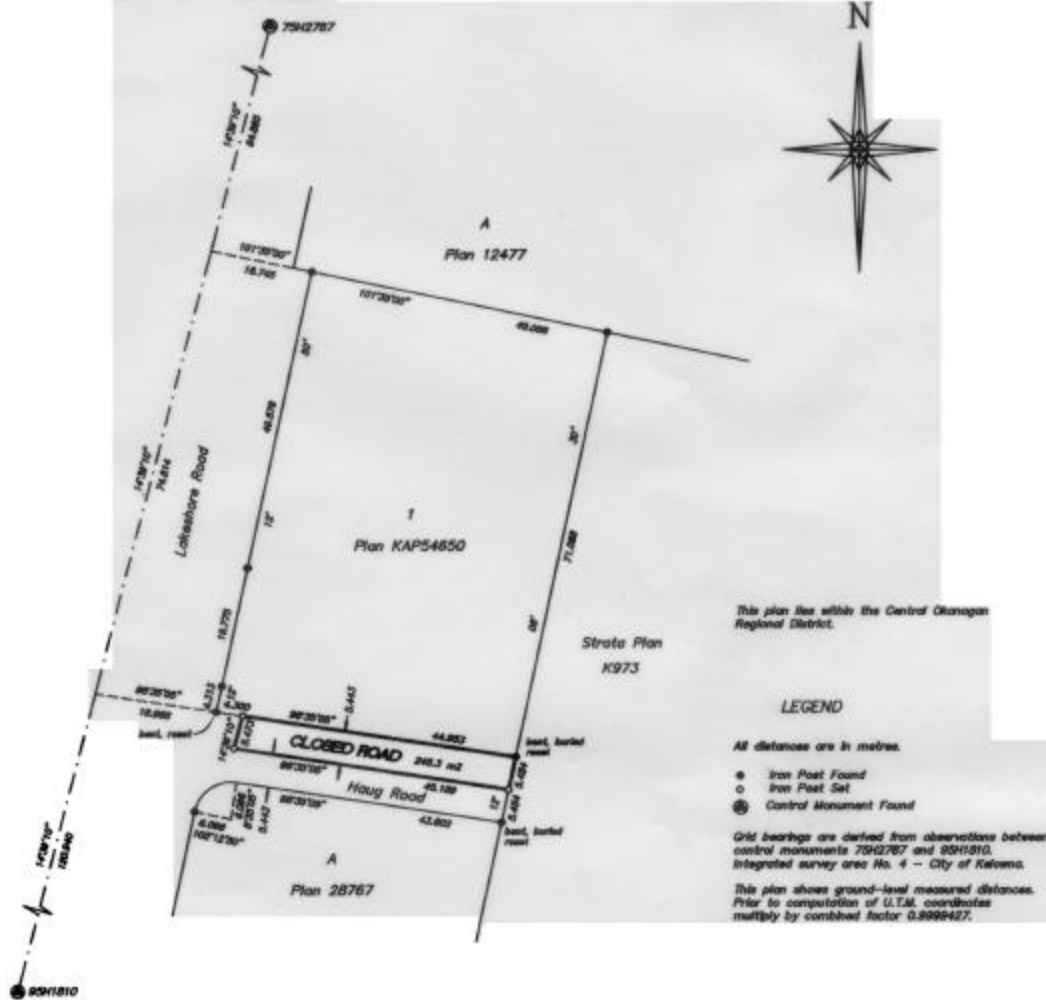

## **ROAD CLOSURE AND REMOVAL OF HIGHWAY DEDICATION BYLAW 9281 Haug Road Adjacent to 3957 Lakeshore Road**

### **PUBLIC NOTICE**

In general terms, the Community Charter permits a municipality to close a road and remove the highway dedication. In order to complete this process Council must adopt a Road Closure and Removal of Highway Dedication Bylaw and must advertise its intent to adopt the bylaw.

Pursuant to Section 40 of the Community Charter, notice is hereby given that the Council of the City of Kelowna proposes to consider adoption of Road Closure and Removal of Highway Dedication Bylaw 9281 at their regular meeting held 24<sup>th</sup> day of August, 2004. Bylaw 9281 authorizes the City to permanently close and remove the highway dedication of a portion of Haug Road, being in the City of Kelowna, British Columbia.
