RE: AWARD OF CONSTRUCTION CONTRACT TE 05-07 KLO Road Widening

RECOMMENDATION:

THAT the Contract TE 05-07 for construction of the KLO Road Widening be awarded to Peters Bros. Construction Ltd. for the amount of \$3,992,942.54, including GST;

AND THAT the Mayor and City Clerk be authorized to execute the Contract on behalf of the City.

BACKGROUND:

In conjunction with the 20-Year Servicing Plan, the City is proposing to widen KLO Road to two lanes in each direction with a centre two-way left turn lane. In addition, a second northbound lane through and two eastbound to northbound left turn lanes will improve the KLO/Benvoulin intersection.

The design of the road is as per the City's Subdivision, Development and Servicing Bylaw No. 7900, drawing SS-R9.

The work to be performed includes the construction of approximately:

- 1900 m of storm sewer;
- 200 m of water main;
- 750 m of sanitary sewer;
- 2,500 m of sidewalk;
- 2,650 m of concrete curb and gutter; and
- 60 new maple boulevard trees.

In response to the City's invitation to Tender TE05-07, three bids were received, as shown:

\$4,605,263.95

*Arithmetic error corrected that did not materially affect the tender.

Our Consultant, Stantec Consulting, has reviewed the bids for accuracy and arithmetic errors and has provided the City with a tender analysis and the corrected bids. Peters Bros. Construction Ltd. has complied with the tender specifications and drawings and included the specified Bid Bond and Surety Consent for Performance and Labour and Material Payment bonds.



Upon award, construction of this project is anticipated to begin at the end of June and completed by the end of November, 2005 with final lift paving to occur in the spring of 2006.
