BYLAW NO. 9377

Road Closure and Removal of Highway Dedication Bylaw **(Land Adjacent to 140 Dougall Road)**

A bylaw pursuant to Section 40 of the Community Charter to authorize the City to permanently close and remove the highway dedication of a portion of highway on the Lane between Dougall Road and Froelich Road

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. That portion of highway attached as Schedule "A" comprising 269.5 m² shown in bold black as Closed Road on the Reference Plan prepared by H.G. van Gurp, B.C.L.S. and completed on 28th day of February, 2005, is hereby stopped up and closed to traffic and the highway dedication removed.
2. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.

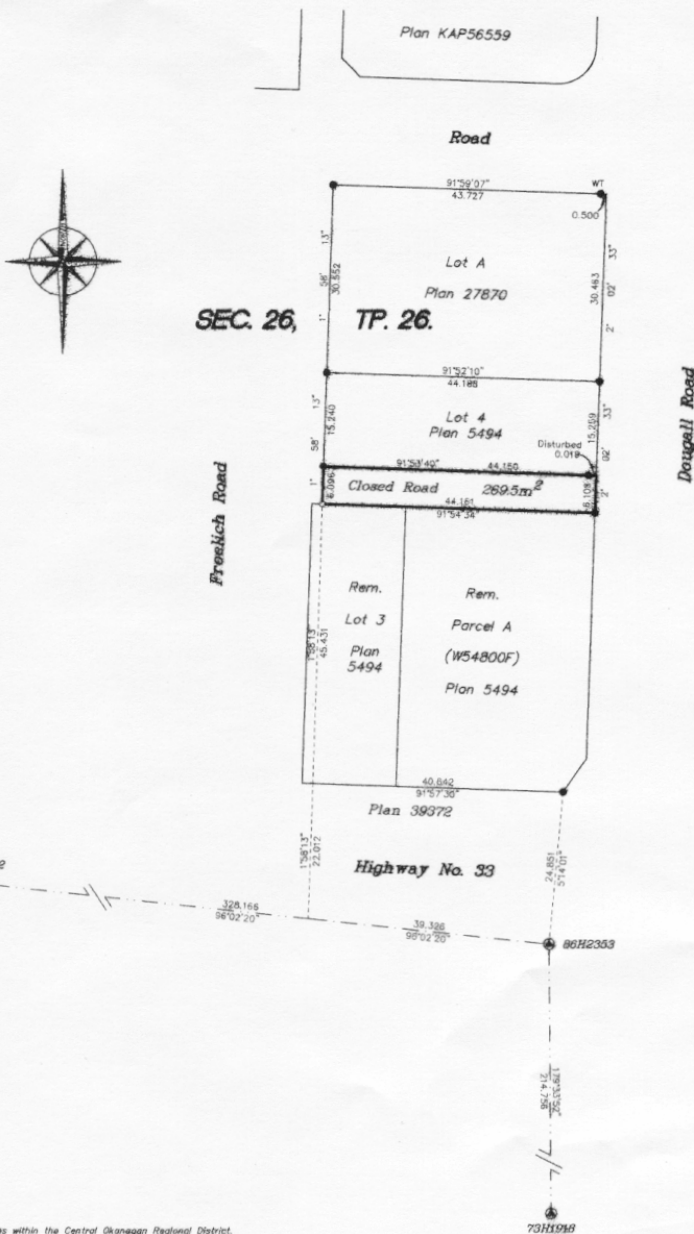
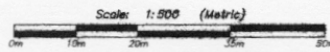
