BE IT RESOLVED THAT the City of Kelowna calls on their MPs to allow speedy passage of and vote for Bill C-48;

BE IT FURTHER RESOLVED THAT the City of Kelowna urges the Government of Canada, following passage of Bill-C48, to work with FCM to ensure an efficient and speedy roll-out of the new funding, with the Provinces and Territories wherever possible, and directly with municipalities where Provincial/Territorial involvement is not possible or immediately forthcoming; and

BE IT FURTHER RESOLVED THAT the City of Kelowna urges the Government of Canada to work with FCM to secure an effective long term national housing strategy;
