## BYLAW NO. 9427

### **Road Closure and Removal of Highway Dedication Bylaw** **(Lane between Bernard Avenue and Lawson Avenue)**

**A bylaw pursuant to Section 40 of the Community Charter to authorize the City to permanently close and remove the highway dedication of a portion of a lane between Bernard Avenue and Lawson Avenue**

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. That portion of highway attached as Schedule "A" comprising 176.4 m<sup>2</sup> shown in bold black as CLOSED ROAD on the Reference Plan prepared by Neil R. Denby, B.C.L.S. and completed on 22nd day of June, 2005, is hereby stopped up and closed to traffic and the highway dedication removed.
2. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid and to affix the Corporate Seal of the said City thereto.

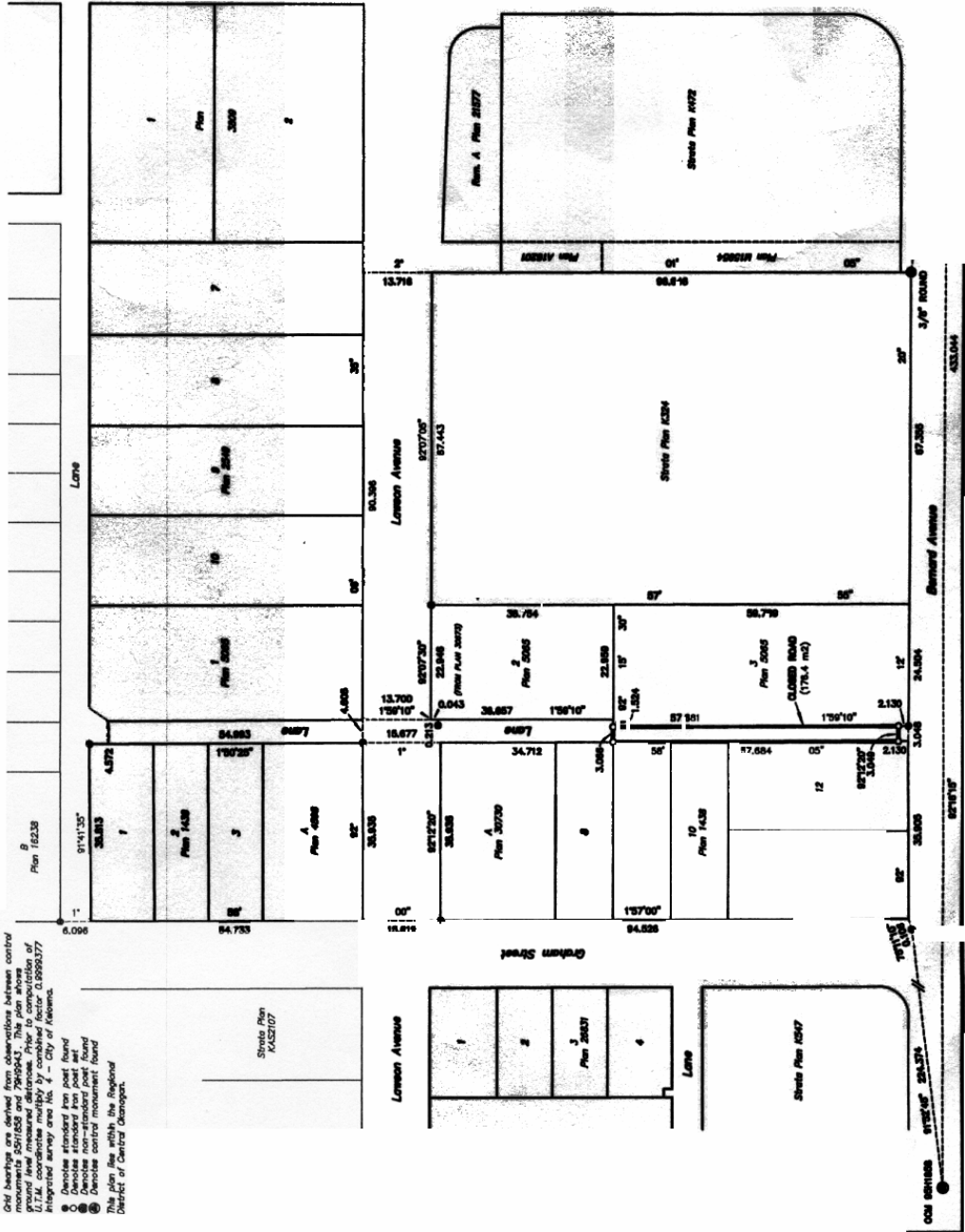
