REPORTS

3.1 Letter dated August 16, 2005 from Kelowna Canada Day Concerts Society re: Funding Shortfall – 2005 Concert

Staff:

- The Canada Day Concerts Society was formed not long after Mistro Leonard Camplin left the Symphony Society, and has piggy backed on the Folkfest since then. This worked well because they used the same infrastructure in the setup which was only about \$2,000 and that costs was paid by the City. However, when the event moved from the Memorial Area to Prospera Place, set-up costs increased; the additional money is primarily for more professional audio services.
- Funding for Canada Day is a base budget item. Rather than giving them a grant to cover their shortfall, suggest the request for funding assistance be referred back to staff for review and report back. Staff have been working on getting the Life and Arts Festival, Parks Alive, the whole Canada Day event, and possibly the Regatta under one non-profit society that could run all of the events under the City's leadership. Anticipate bringing that report forward to Council in the near future.

Council:

- Concerned about leaving the Society with outstanding debt when it was incurred in the Centennial Year.
- Agreed to provide a one-time grant, but not for the full amount
- Staff to inform the Society that in future they will be expected to be part of the whole picture and to work together more with the other event organizers.
- Staff to consider allowing other groups to also use the stage in future so the music is not the same every year, and to consider charging a toonie rather than relying on donations for admittance.
