Subject: 2005 General Local Government Elections

Recommendation:

THAT the final report from the Chief Election Officer for the 2005 General Local Government Election be received;

AND THAT Council send a letter to the Minister of Community Services recommending that Part 3 of the *Local Government Act* be reviewed with respect to any timely amendments or updates, and in particular with respect to possible opportunities for alternative forms of voting that would allow electors to cast absentee ballots.

Background:

Official Results:

The official results of the 2005 election were declared, as required by the *Local Government Act*, on Wednesday, November 23, 2005. A summary of those results, with a summary of the ballot account, is attached to this report.

Advance Voting Opportunities:

The dates, times, and location of advance voting opportunities were set by Council, through Bylaw No. 9440, which was adopted on June 27, 2005. There were two opportunities, both at Parkinson Recreation Centre, on November 9 and November 15, 2005, from 8:00 a.m. to 8:00 p.m. Two thousand, three hundred and thirty five electors cast ballots at the advance voting opportunities.

Special Voting Opportunities:

Special voting opportunities were offered to all facilities in Kelowna licensed to provide "complex care" to their residents, as well as to Kelowna General Hospital. Six special voting opportunities were held in the days prior to general voting day at the facilities themselves, with special voting occurring at Kelowna General Hospital on general voting day itself. Special voting is limited, by Bylaw No. 9440, to patients, residents and staff of the facilities at which the voting was held. A total of three hundred and ninety two electors cast ballots at the special voting opportunities.

General Voting Opportunities:

General voting was held on November 19, 2005, from 8:00 a.m. to 8:00 p.m. at sixteen locations spread throughout Kelowna. This was in increase of six from the number of general voting locations at the 2002 local government election. Turnout was fairly evenly spread throughout all locations, with the exceptions of the Dorothea Walker Elementary School location (2748) and the Rutland Senior Secondary School location (2477), which received higher numbers than the

others (both locations are traditionally busy), and the South Kelowna Elementary School location (241) which received much lower numbers.

Turnout in municipal elections in British Columbia traditionally averages around 30%, with turnout generally decreasing in reverse proportion to the size of the community. Estimated turnout for the City of Kelowna election this year was 31.45%, up from less than 25% in 2002.

Alternative Opportunities for Voting:

There are several other jurisdictions in Canada in which relevant election legislation provides for a variety of alternative voting methods, including internet voting, general mail ballot voting and other methods for absentee voting. The existing *Local Government Act* provisions in British Columbia are much more restrictive in the options that we can provide to our electors. We had several inquiries during this election from City of Kelowna residents who, for example, were to be out of the country after the beginning of November and would therefore miss both the general voting and advance voting opportunities. Amendments to the *Local Government Act*, which would have to be made by the Province, to provide for some alternative voting methods may allow such residents to exercise their franchise in future elections. We recommend that the Minister of Community Services be requested to review such alternative methods with a view to putting forward the necessary related amendments prior to the 2008 general local government elections in British Columbia.
