

# CITY OF KELOWNA

## BYLAW NO. 9614

### Amendment No. 14 to City of Kelowna Electricity Regulation Bylaw No. 7639

---

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT City of Kelowna Electricity Regulation Bylaw No. 7639 be amended by:
  - (i) Deleting Appendices C-1 to C-12, inclusive, in their entirety and replacing them with new Appendices C-1 to C-12 attached to and forming part of this bylaw.
  - (ii) Deleting Appendix C-13 in its entirety and replacing it with the new Appendix C-13 attached to and forming part of this bylaw.
2. Section 1.(i) of this bylaw will come into full force and be binding on all persons as of August 16, 2006.
3. Section 1.(ii) of this bylaw will come into full force and be binding on all persons as of the date of adoption.
4. This bylaw may be cited for all purposes as "Bylaw No. 9614 being Amendment No. 14 to City of Kelowna Electricity Regulation Bylaw No. 7639".
