RECOMMENDATION

THAT City Council approve the request and recommendations of the Licence and Bylaw Enforcement Supervisor to amend the noted sections of the Second Hand Dealers and Pawnshop Bylaw No. 9227 as outlined in this report,

AND THAT City Council approve the request and recommendations of the Licence and Bylaw Enforcement Supervisor to amend the noted sections of the Ticket Information Utilization Bylaw No. 6550-89 as outlined in this report.

AND FURTHER THAT the required amending bylaws be advanced for reading consideration by Council.

BACKGROUND

In consultation with the RCMP and City solicitor and in order to enhance and improve our inspection services, it became evident that additional amendments to the Second Hand Dealers and Pawnshop Bylaw along with the Ticket Information Utilization Bylaw was necessary for enforcement purposes and to expedite the court process.

We are recommending the following amendment to the **Second Hand Dealers and Pawnshop** Bylaw No. 9227 as follows:

Add New Section:

- Section 3.2 "A person commits an offence by recording or supplying false or misleading information:
 - a) In the register
 - b) In any transmission to the specified database under subsection 2.3(c)

Renumber Sections:

Renumber current section 3.2 to read 3.3 Renumber current section 3.3 to read 3.4 Re: Amendments to Second Hand Dealers and Pawnshop Bylaw No. 9227 Amendments to Ticket Information Utilization Bylaw No. 6550-89

Secondly, we are recommending that Council approve the following amendments to the **Ticket Information Utilization Bylaw No. 6550-89** as outlined:

Page 1 - Section 3 - Amend to Read:

"The words or expressions set forth in Column 1 of Schedules 2 through 27 to the Bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions."

Page 1 - Section 4 - Amend to Read:

"The amounts appearing in Column 3 of Schedules 2 through 27 of this bylaw are the fines set pursuant to Sections 264 and 265 of the Community Charter for the corresponding offences designated in Column 1.
