Amendment No. 68 to City of Kelowna Ticket Information Utilization Bylaw No. 6550-89

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

- (f) deleting the words "Fail to identify or tag property" from Schedule 27 and replacing them with the words "Fail to tag or separate property";
- (g) adding the following new provisions to Schedule 27 in the appropriate location:

"Record or supply false/misleading information	3.2(a)	\$100.00
Transmit false/misleading information	3.2(b)	\$100.00
