## September 25, 2006

A Regular Meeting of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Monday, September 25, 2006.

## 1. <u>CALL TO ORDER</u>

Mayor Shepherd called the meeting to order at 1:35 p.m.

## 3.0 <u>Communities in Bloom</u>

Mark Tompkins, Communities in Bloom Committee:

- Announced that the City of Kelowna and the District of Summerland were in the Canadian Classic mentoring program and won the competition nationally.
- Presented the award to Mayor Shepherd and to the three Summerland representatives.
  - 3.1 RCMP Supt. Bill McKinnon re: Update on Policing Activities

Supt. McKinnon:

- Introduced Const. Annie Linteau, media spokesperson for the Kelowna RCMP Detachment.
- Gave an overview of the activity statistics and crime statistics for the month of August.
- Suggested that in the next Citizens Survey the 85% respondents who used the community policing offices be asked how many had a **need** to use the community policing offices.
- Shared some of the challenges in responding to the demands on policing while dealing with the resourcing shortage through the RCMP.

Mayor Shepherd altered the order of business and advised that Councillor Gran's Councillor Item regarding the RCMP Crime Reduction Strategy would be dealt with next.

## 9(a) Councillor Gran re: <u>RCMP Crime Reduction Strategy</u>

### Moved by Councillor Gran/Seconded by Councillor Hobson

**<u>R921/06/09/25</u>** THAT WHEREAS the RCMP has initiated a Crime Reduction Program in the Province of British Columbia in September of 2005 and is currently running pilot projects at five locations across the Province;

AND WHEREAS there is a second critical element to this strategy requiring an Integrated Criminal Justice model which would include five Regional Criminal Justice Boards, composed of the RCMP Detachment Commanders, Regional Crown Counsel, Corrections and Court Services, Health Services and community representation, reporting to a Provincial Criminal Justice Board that would include the Attorney General, Solicitor General, Chiefs of Police, Chief Judge, Chief Justice and Senior Executives;

AND WHEREAS this strategy would unify the Criminal Justice System, engage communities and invite input and involvement, improve upon the efficiency of the Criminal Justice System, prevent and deter crime, reduce offender recidivism, reduce overall crime, reduce the fear of crime, and thereby enhance the safety and security of our citizens and our communities, improving quality of life;

THEREFORE BEIT RESOLVED THAT a letter be sent to Premier Gordon Campbell advising that the City of Kelowna Council supports this RCMP Crime Reduction initiative and urging that the Provincial Government do the same;

AND THAT the letter also be sent to MP Ron Cannan and MLAs Sindi Hawkins, Al Horning and Rick Thorpe;

AND FURTHER THAT the letter also be sent to the Union of British Columbia Municipalities to distribute to its members.

### 3.2 Clint McKenzie, Executive Director, Downtown Kelowna Association re: Update - Back Alley Garbage Solutions (BAGS) Program

Clint:

- Phase 1 included the removal of just over 70 dumpsters from alleys west of Pandosy. The deadline for removal of just over 55 dumpsters in the Phase 2 area, east of Pandosy to Richter Street, is this Sunday, October 1<sup>st.</sup>.
- The DKA is continuing to augment the alley lighting program; just under 60 lights have been installed to date.
- Showed a video of a mid-summer RCMP walkabout through the alleys to show the improvement in the Phase 1 area. Also displayed before and after photos of dumpsters in the Phase 1 alleys.
- Asked for continued enforcement of the current bylaw dealing with dumpsters and continued support for alternative alley uses.

(b) Affordable and Special Needs Task Force

Councillors Letnick and Rule advised that the Task Force will be holding Open Houses for input from the community on October 30 and November 1, 2 and 3, 2006, hopefully in the Community Policing Stations. Will do a media release as soon as the location and time have been set. The Task Force is still targeting to bring forward its final recommendations for Council at the November 20, 2006 Regular meeting.

(c) <u>Recreation Parks & Cultural Services Task Force</u>

Councillor Hobson advised that the task force is working on a master planning process for recreation parks and culture and expects to be back to Council with final recommendations next spring.

(d) <u>Bicycle Access to University of British Columbia-Okanagan</u>

A motion moved by Councillor Hobson and seconded by Councillor Rule for the Ministry of Transportation to consider including a bicycle access in the design of the UBC-O flyover was not voted on. Instead Council agreed to have staff check with the Ministry of Transportation to see if the design already includes a bike lane and if not to find out the cost implications of adding a bike lane on the flyover.
