BYLAW NO. 9555

Amendment No. 8 to Traffic Bylaw No. 8120

The Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT "Traffic Bylaw No. 8120" be amended by deleting subsection 2.5.1 Sidewalks and replacing it with the following:

2.5.1 Sidewalks. **Owners** or **Occupiers** of real property shall remove snow, ice, or **rubbish** from the **sidewalk** and walkways bordering (whether directly adjacent to, or separated by a boulevard, landscaping, or other portion of either the property or the road) on the real property owned or occupied by them within 24 hours of the accumulation of such snow, ice or **rubbish**. Notwithstanding this provision, **owners** or **occupiers** of real property bordering the following stretches of road shall be exempt from removing such snow, ice or **rubbish** from such **sidewalk** along those stretches only:
