Re: Kelowna Municipal RCMP Detachment Policing Activity Report - February 2007

Please note below the policing report reflecting key activities undertaken by the Kelowna RCMP for the month of February, 2007. I will highlight the key statistical data for the most common criminal activities, and provide a short narrative overview of criminal trends and resources.

The spike in theft over \$5,000 this past month is due in large part to a number of internal thefts

by past and present employees of businesses with no trend noted.

The number of robberies increased in the month of February in large part to two different groups; a warrant has been issued for a number of young offenders from Calgary who committed several robberies in Rutland, and two other males were taken into custody after they committed at least two robberies.

Highlights:

A traffic stop was initiated at the corner of Martin & Ethel Street. After observing open liquor in the vehicle, a further search by the attending member and Kelowna's Drug Unit located a quantity of cocaine (approximately 14 grams), drug paraphernalia, and cell phones.

A search warrant was executed at a residence which resulted in the seizure of 1063 plants. No one has been arrested as yet, however, charges are pending.

In another unrelated search, \$21,000 cash and 1 ounce of cocaine was seized from a residence. Two people have been charged.

Downtown Enforcement Unit (DEU)

DEU, GIS Drugs and UC Operators joined in a Prostitution Sting at the end of February. In just a few hours, 4 girls were arrested and 'red-zoned'. The next day, 1 of these females was arrested for breaching her red-zone conditions. DEU also assisted GIS Drug Section with the execution of a warrant on a house and the subsequent arrest of 2 individuals involved in that file. DEU continues to assist and work with any other units with Kelowna but primarily with GIS Drugs as DEU is the foot that hits the pavement in the areas that most dealers are trying to get to. These users routinely provide information to the DEU members which in turn gets passed onto GIS Drugs.

Traffic Stats

DEU has been in contact with Bylaws and it is expected that a closer working relationship with them will continue to grow. Once the members of DEU understand the importance of using the Bylaw tickets to their fullest potential it is expected that the number of Bylaw tickets issued will grow substantially and the number of red-zones stemming from these charges will increase as well. Routine meetings with Bylaws and DEU will start in the month of March.
