CITY OF KELOWNA BYLAW NO. 9789

Capital Works, Machinery and Equipment Reserve Fund Expenditure Bylaw, 2007

WHEREAS, there is an unappropriated balance in the Capital Works, Machinery and Equipment Reserve Fund established under Bylaw No. 5436-82 of Twenty - Four Million, Three Hundred Fifty-Four Thousand, Nine Hundred Sixteen Dollars (\$24,354,916.00) as at January 1st, 2007.

AND WHEREAS, it is deemed desirable to expend a portion of the monies set aside under said Bylaw No. 5436-82 for the purpose of general capital expenditures set out below;

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. The sum of Twenty - Four Million, Three Hundred Fifty - Four Thousand, Nine Hundred Sixteen Dollars (\$24,354,916.00) is hereby appropriated from the Capital Works, Machinery and Equipment Reserve Fund to be expended in 2007 for the following purposes:

- 2. The expenditure to be carried out by the monies hereby appropriated shall be more particularly specified and authorized by resolution of Council.
- 3. Should any of the above remain unexpended after the expenditures hereby authorized have been made, the unexpended balance shall be returned to the credit of the Capital Works, Machinery and Equipment Reserve Fund.
- 4. This bylaw may be cited as the "Capital Works, Machinery and Equipment Reserve Fund Expenditure Bylaw, 2007, No. 9789".
