PURPOSE: TO OBTAIN COUNCIL SUPPORT FOR A PATRON PARTICIPANT ENTERTAINMENT ENDORSMENT FOR AN EXISTING FOOD PRIMARY LIQUOR LICENSE ON THE MV THE BOARDROOM

1.0 RECOMMENDATION

THAT Council support a Patron Participation Entertainment Endorsement for existing Food Primary Liquor License Number 302016 located on the M.V. The Boardroom berthed at 100 Bernard Avenue;

AND THAT Council direct staff to forward the appropriate resolution to the Liquor Control and Licensing Board in Victoria.

2.0 SUMMARY

The applicant is seeking Council support for a Patron Participation Entertainment Endorsement to the existing Food Primary Liquor License. This endorsement would allow any form of entertainment that encourages patrons to participate, such as sing-along, dancing and karaoke, or perform stand-up comedy routines.

4.0 LIQUOR CONTROL AND LICENSING BRANCH CRITERIA

- (a) The potential for noise if the application is approved:

No concerns have been identified; it is not anticipated that there will be any change to the existing level of noise generated by non-participation entertainment.

- (b) The impact on the community if the application is approved:

No concerns have been identified; it is not anticipated that there will be any change to the existing level of impact on the community as a result of the patron participation entertainment endorsement.

- (c) Whether the amendment may result in the establishment being operated in a manner that is contrary to its primary purpose:

It is not anticipated that the amendment will result in the establishment being operated in a manner that is contrary to its primary purpose. The applicant advises that the business, Executive Houseboat Charters Inc. offers the public boat cruises on Okanagan Lake which includes a dinner and music. The applicant would like to provide patrons the opportunity to dance to the music provided, whether live or recorded.

- (d) The views of residents:


Views of the residents will be gathered at a public meeting in accordance with Council Policy #315.
