With this donation we were able to buy a new digital reader printer for the genealogy staff. We wanted to highlight the fact that this group gives every year for special things that library budget does not cover.

 - Mission Branch is getting busier and the location is wonderful.
 - Rutland Branch is doing well and have huge line ups for the internet services but the location at the Mall isn't doing as well.
