BYLAW NO. 9866

Amendment No. 2 to Second-Hand Dealers and Pawnbrokers Bylaw No. 9227

WHEREAS the Council considers it necessary to regulate the businesses of Second-Hand Dealers and Pawnbrokers within the City of Kelowna;

NOW THEREFORE the Municipal Council of the City of Kelowna in open meeting assembled enacts as follows:

1. THAT **SECTION 2 – SECONDHAND DEALERS AND PAWNBROKERS** be amended by:
 - (a) deleting the words “, and birth date” in sub- paragraph 2.2(a) in their entirety;
 - (b) deleting sub-paragraph 2.2 (h) in it's entirety and renumbering the subsequent sub-paragraphs;
 - (c) deleting the words “a report of the entry in the electronic register” in sub-paragraph 2.3 (c) and replacing it with the words “information pertaining to the identification”;
 - (d) deleting in it's entirety sub-paragraph 2.3 (e) and renumbering the subsequent paragraphs; and
 - (e) deleting sub-paragraphs 2.6 and 2.7 in their entirety and renumbering the subsequent paragraphs.
3. AND THAT Schedule “A”, SECOND HAND & PAWNBROKER DEALER’S REPORT be replaced with a new Schedule “A” SECOND HAND & PAWNBROKER DEALER’S REPORT attached to and forming part of this bylaw.
4. This bylaw may be cited as “Bylaw No. 9866, being Amendment No. 2 to Second Hand Dealer and Pawnbroker Regulation Bylaw No. 9227”.
5. This bylaw shall come into force on the date of adoption.
