BYLAW NO. 9837

Amendment No. 16 to City of Kelowna Electricity Regulation Bylaw No. 7639

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

- 1. THAT City of Kelowna Electricity Regulation Bylaw No. 7639, section 3.9 **Definitions**, be amended by changing 'Electrical Manager' to 'Electrical Administration Manager' and by replacing Electrical Manager' to 'Electrical Administration Manager' throughout the bylaw in its appropriate location;
- 2. AND THAT City of Kelowna Electricity Regulation Bylaw No. 7639, **SCHEDULE B,** be amended by:
 - (a) adding to **SECTION I GENERAL**, sub-section B-3. <u>MINIMUM SERVICE CAPACITY OF RESIDENTIAL</u> the sentence "Any legal property with more than one 200 amp service with a single meter and single family dwelling is deemed to be multi unit." after the sentence "Only one service shall be allowed"; and
 - (b) deleting the words "SECTION II EXISTING OVERHEAD SERVICES" and replacing it with the words "SECTION II EXISTING AND/OR NEW OVERHEAD SERVICES";
 - (c) deleting **SECTION III UNDERGROUND SERVICES** sub-section B-11 <u>RESIDENTIAL SERVICES</u> sub-paragraph B-11.2 and replacing it with a new sub-paragraph B-11.2 as follows:
 - "B-11.2 The **Customer** shall be responsible for 100% of all trenching, conduit and cable from customers point of service to the City of Kelowna point of attachment for all underground service. A minimum 7.62 m., (3in) PVC of DB2 conduit with bell ends and long sweep bend shall be required.";
 - (d) delete in its entirety the title for sub-paragraph B-12 under **SECTION III UNDERGROUND SERVICES** and replace with the following:

"MULTII UNIT, GENERAL SERVICE COMMERCIAL AND INDUSTRIAL";

- (e) delete in its entirety, **SECTION III UNDERGROUND SERVICES** subparagraph B-12.1 and replace it with the following:
 - "All Multi unit, commercial and industrial services shall be installed underground unless specific approval is granted by the **Electrical Administration Manager** for an overhead service or unless otherwise provided for the City of Kelowna Subdivision Bylaw No. 6050-86.";
- (f) delete the sentence that reads "All cost of hi-potting to be borne by **Customer**." in **SECTION III UNDERGROUND SERVICES**, sub-paragraph B-12.2;

- (g) add to the end of the sentence ", or 25% of actual cost of the transformer." in **SECTION VIII TRANSFORMER INSTALLATION**, sub-paragraph B-40;
- (h) delete in its entirety **SECTION VIII TRANSFORMER INSTALLATION** subparagraph B-41 and replace with the following:

"Transformer capacity over 500 KVA shall be approved by the **Electrical Administration Manager**, purchased by the **Customer** and installed by an Electrical Contractor. The **City** will contribute a maximum of 75% only of the cost of a 500 KVA transformer, additional cost for transformers greater than 500 KVA is to be paid by the **Customer**."

- 3. AND THAT City of Kelowna Electricity Regulation Bylaw No. 7639, SCHEDULE C, CITY OF KELOWNA ELECTRICAL UTILITY BILLING RATES & STREET LIGHTING, MISCELLANEOUS & CONNCETION CHARGES be amended by:
 - (a) deleting appendix C-13, in its entirety and replacing it with a new appendix C-13 as follows:

"APPENDIX C-13

Electrical Service Connection Charge for Single Family Properties: (All, trenching, conduit and cable from city's point of attachment to the customers point of attachment are paid for by the customer)

1. Basic:

	Underground	Overhead
200 amp service or less, during regular hours	\$260	\$260
200 amp service or less, after regular hours	\$460	\$460

2. Temporary Service:

200 amp service or less, during regular hours	\$260	\$260
200 amp service or less, after regular hours	\$460	\$460

3. Service Upgrade or Relocation Underground and/or Overhead:

200 amp service or less, during regular hours	\$260	\$260
200 amp service or less, after regular hours	\$460	\$460

^{**} All residential **service** greater than 200 amps will be considered commercial and will pay 100% of actual costs based on a cost estimate."

- 4. AND THAT AND THAT City of Kelowna Electricity Regulation Bylaw No. 7639, SCHEDULE D, CITY OF KELOWNA ELECTICAL BILLING AND COLLECTION REGULATIONS be amended by:
 - (a) deleting in its entirety section D-8. ADMINISTRATION FEES, sub-section D-8.1 and replacing it with the following:

"D-8.1 The fee for making a standard new utility billing account application shall be as follows:

```
Effective February 16, 1999 – Twenty-three dollars ($23.00) Effective January 16, 2000 –Twenty –seven dollars ($27.00) Effective October 30, 2007 Thirty dollars ($30.00)
```

In the case of multiple utility billing account applications, where two or more applications are to be made for one Customer at the same time at lone location the fee shall be as follows:

```
Effective February 16, 1999 – Twenty-three dollars ($23.00) Effective January 16, 2000 –Twenty –seven dollars ($27.00) Effective October 30, 2007 -Thirty dollars ($30.00)
```

For each application.";

(b) deleting in its entirety section D-8. <u>ADMINISTRATION FEES</u>, sub-section D - 8.3 and replacing it with the following:

"If it is necessary to re-read a meter more than twice in one calendar year the following fees may apply:

```
Effective February 16, 1999 – Twenty-three dollars ($23.00) Effective January 16, 2000 –Twenty –seven dollars ($27.00) Effective October 30, 2007 - Fifty-five dollars ($55.00)";
```

(c) deleting in its entirety section D-8. <u>ADMINISTRATION FEES</u>, sub-section D - 8.4 and replacing it with the following:

"The fee for a change of service shall be as follows:

```
Effective February 16, 1999 – Twenty-three dollars ($23.00) 
Effective January 16, 2000 –Twenty –seven dollars ($27.00) 
Effective October 30, 2007 - Thirty dollars ($30.00)
```

If it is necessary to call out a work crew the fee shall be Two hundred and Sixty dollars (\$260.00) during call-out hours."; and

(d) deleting in its entirety section D-8. <u>ADMINISTRATION FEES</u>, sub-section D - 8.5 and replacing it with the following:

"The fee for a reconnection to supply after disconnection violation of this Bylaw shall be as follows:

```
Effective February 16, 1999 – Twenty-three dollars ($23.00) 
Effective January 16, 2000 –Twenty –seven dollars ($27.00) 
Effective October 30, 2007 – Thirty dollars ($30.00)
```

If it is necessary to call out a work crew the fee shall be Two hundred and Sixty dollars (\$260.00) during call-out hours.

If it is necessary to disconnect/reconnect at the pole during regular hours the fee shall be Two Hundred and Sixty dollars (\$260.00) per call out.

If it is necessary to disconnect/reconnect at the pole during call-out hours the fee shall be Four Hundred and Sixty dollars (\$460.0) per call out."

- 6. This bylaw may be cited for all purposes as "Bylaw No. 9837 being Amendment No. 16 to City of Kelowna Electricity Regulation Bylaw No. 7639".
