
## PLANNING & DEVELOPMENT SERVICES COMMENTS 1.0

At the December 11th, 2007 Public Hearing City Council deferred this rezoning application until the Bylaw infractions registered on the subject property were resolved. The Bylaw Enforcement Division had received complaints regarding weekly holiday rentals and the music studio located in the garage. In order to satisfy the Bylaw Enforcement Division it was determined that the applicant would have to cancel the business licence for the music studio, have the studio inspected to ensure that it has been dismantled, and prove that weekly rentals are no longer occurring on the subject property. All of this has taken place and at this point in time the Bylaw Enforcement Division has closed both the Bylaw infraction files for this property. Staff have worked with the applicant to ensure that the subject property conforms to the Zoning Bylaw and that the potential for future conflicts has been reduced.


