# CITY OF KELOWNA BYLAW NO. 9913 Amendment No. 19 to City of Kelowna Electricity Regulation Bylaw No. 7639

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

- 1. THAT City of Kelowna Electricity Regulation Bylaw No. 7639 be amended by:
  - (i) Deleting Apendices C-1, C-2, C-4, C-5, C-8, C-9, C-10, C-11 and C-12, in their entirety and replacing them with new Appendices C-1, C-2, C-4, C-5, C-8, C-9, C-10, C-11 and C-12 attached to and forming Part of this bylaw.
- 2. This bylaw will come into full force and be binding on all persons on the date of adoption.
- 3. This bylaw may be cited for all purposes as "Bylaw No. 9913 being Amendment No. 19 to City of Kelowna Electricity Regulation Bylaw No. 7639".
