# **Property Crime Section - Highlights**

Kelowna RCMP's newly formed "Target Team" assisted by other plainclothes officers and general duty officers, executed a search warrant at a local Motel in which a significant quantity of crack cocaine (2 ounces), stolen property, and two handguns were seized. One of the handguns was found to be loaded. During this incident, one individual well known to Police, attempted to flee by jumping out the rear window. He has been charged with numerous offences (related to drugs and weapons) and remains in custody. This is an example of how the Kelowna RCMP intend on utilizing a crime-reduction strategy to focus on prolific offenders and high crime areas. We are anticipating that this unit will grow over the course of the year which will in turn see more strength towards reducing the crime generated at the hands of prolific offenders.

#### General Information

### Youth Forum on Parks and Open Spaces

Although the Mayor's Youth Forum on Parks and Open Spaces identified "safety" as the primary barrier to park use by youth it is important to acknowledge that the summary of comments revealed some consistency of opinion that park rules, the presence of authority figures, combined with lack of youth-appropriate activities, posed equally significant barriers.

Having said that, a number of initiatives undertaken by the RCMP will ensure our parks are afforded the resources necessary to ensure they remain a safe environment for everyone in our community:

# Coordinated Enforcement Committee:

This committee has been brought together by Corporal Lee Hamilton of our Downtown Enforcement Unit and Garth Letcher, Community Policing Coordinator, to pro-actively deal with the problems within the downtown core of the City of Kelowna, as well as parks and beach accesses throughout the city.

The committee's stated mission is "To ensure a high level and consistent policing strategy that will reduce the number of complaints pertaining to problems within the downtown core, on the beaches, beach accesses and city parks and in return making these areas a safer location for all people to attend while allowing the City of Kelowna to demonstrate to the residents and tourists alike that these areas are safe to enjoy."

The committee consists of representatives from Parks Department, private security companies, Downtown On Call (formerly Downtown Patrol), Bylaw Department and RCMP.

The Coordinated Enforcement Committee will direct the following resources to address identified targets or "hot spots":

- 1. Officers dedicated to the Downtown Enforcement Unit
- 2. Foot patrol officers
- 3. RCMP and Bylaw Bicycle Patrol officers
- 4. Gator Patrols, enhanced to include Ben Lee Park & Rutland portion of Greenway
- 5. Auxiliary Constable Program increased number of A/Csts will permit greater visibility
- 6. Target Team (Targets prolific offenders)
- 7. Drug Enforcement continued use of random undercover operations.

# <u>Prime</u>

Due to a significant change in our records management with the implementation of a new program (PRIME), we will be unable to provide Mayor and Council with statistical data for the next couple of months.
