- Staff made the decision to cancel this event. There was not sufficient time to have the Outdoor Events Committee meet, as half of the committee members do not work for the City. The objective is to ensure a safe and healthy environment for everyone as well as affected neighbours. In this case, we had only 2 days before the event was to start. Staff felt that it was not possible to make an appropriate decision in this short time frame. This same carnival applied in the past and received permits to operate and have operated under other permit holders as well. They had an administration glitch at their end that caused them not to apply for this permit before arriving. They have stated that they are happy to look for other sites in Kelowna.
- They were going to set up at a major intersection. Adjacent property owners said they'd actively prohibit parking in their areas. This would have created traffic and parking issues.
