## **BYLAW NO. 10036**

## Text Amendment No. TA08-0005 City of Kelowna

A bylaw to amend the "City of Kelowna Zoning Bylaw No. 8000".

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts that City of Kelowna Zoning Bylaw No. 8000 be amended as follows:

- 1. THAT paragraph 14.4.2 Principle Uses of subsection 14.4 C4 Urban Centre Commercial/C4rls Urban Centre Commercial (Retail Liquor Sales)/C4lp Urban Centre Commercial (Liquor Primary)/C4lp/rls Urban Centre Commercial (Liquor Primary/Retail Liquor Sales) of Section 14 Commercial Zones be amended by adding the principle use "broadcasting studios".
- 2. THAT **Section 13 Urban Residential Zones** be amended by:
  - (a) deleting part (c) of paragraph 13.1.7 Other Regulations of subsection 13.1 RU1 – Large Lot Housing/RU1s – Large Lot Housing with Secondary Suite/RU1h – Large Lot Housing (Hillside Area) in its entirety and replacing it with the following:
    - "A secondary suite, in accordance with Section 9.5, may only be located within a single detached **dwelling** or an accessory **building** that is no closer than 4.5 m to the principal **building**."
  - (b) deleting part (e) of paragraph 13.2.7 Other Regulations of subsection 13.2 RU2 Medium Lot Housing/RU2s Medium Lot Housing with Secondary Suite/RU2h Medium Lot Housing (Hillside Area)/RU2hs Medium Lot Housing (Hillside Area) with Secondary Suite in its entirety and replacing it with the following:
    - "A secondary suite, in accordance with Section 9.5, may only be located within a single detached **dwelling** or an accessory **building** that is no closer than 4.5 m to the principal **building**."
  - (c) deleting part (g) of paragraph 13.3.7 Other Regulations of subsection 13.3 RU3 Small Lot Housing/RU3hs Small Lot Housing (Hillside Area) with Secondary Suite in its entirety and replacing it with the following:
    - "A secondary suite, in accordance with Section 9.5, may only be located within a single detached **dwelling** or an accessory **building** that is no closer than 4.5 m to the principal **building**."
