- The proposed OCP Vision Statement is... "Kelowna will prioritize the protection and expansion of healthy natural ecosystems and productive landscapes. Kelowna will be a liveable and inclusive city defined by walkable, compact and complete urban centres that are connected by active modes of transportation. Kelowna will ensure residents have access to healthy, green and affordable options for all basic needs."
- Confirmed that many of the policies have been retained; however, there has been nine (9) "big moves":
 - Reduce urban sprawl and focus growth in compact and mixed use centres;
 - o Develop a sustainable open space network that protects & enhances sensitive ecosystems and provides exceptional recreational opportunities;
 - Develop distinctive, walkable, mixed-use communities that are welcoming and accessible for all;

- Address housing needs of all residents through a variety of housing options including ownership, rental and non-market housing;
- Provide for safe and convenient passage along transportation networks with priority allocated to active modes of transportation (walking and cycling);
- Improve the energy efficiency and environmental performance of new buildings;
- Emphasize a healthy local food system by supporting commercial agriculture and innovative community agriculture activities;
- Develop green & integrated infrastructure;
- Develop Permit Areas;
- It is anticipated that the OCP will not be adopted until late 2009.

Staff:

- Even though the online survey questions were different from the statistically valid survey questions, staff feel that the online survey is just as statistically accurate.
- Anticipates providing Council with an update by the end of October.

Council/Consultants/Staff:

- There is a need support development/redevelopment in the town centres.
- There is a large amount of already developed single-family zones within the City.
