#### RECOMMENDATION:

THAT the final report from the Chief Election Officer for the 2008 General Local Government Election be received.

## **BACKGROUND:**

#### Official Results:

The official results of the 2008 election were declared, as required by the *Local Government Act*, on Wednesday, November 19, 2008. A summary of those results, with a summary of the ballot account, is attached to this report.

Advance Voting Opportunities:

The dates, times, and location of advance voting opportunities were set by Council, through Bylaw No. 9995, which was adopted on July 21, 2008. There were two advance voting opportunities, both at Parkinson Recreation Centre, on November 5 and November 12, 2008, from 8:00 a.m. to 8:00 p.m. A total of one thousand five hundred and twenty one electors cast ballots at the advance voting opportunities.

**Special Voting Opportunities:** 

Special voting opportunities were offered to facilities in Kelowna that were licensed to provide "complex care" to their residents, as well as to Kelowna General Hospital. Seven special voting opportunities were held in the days prior to general voting day at the facilities themselves, with a special voting opportunity at Kelowna General Hospital on general voting day itself. Special voting is limited, by Bylaw No. 9995, to patients, residents and staff of the facilities at which the voting was held. A total of two hundred and seventy five electors cast ballots at the special voting opportunities.

Mail-In Voting Opportunities:

Mail-in voting opportunities were offered to the electorate in the 2008 Municipal Election with a total of fifty-one requests for mail-in ballot packages. The number of mail-in ballots returned and accepted as valid votes for the election was twenty-five.

**General Voting Opportunities:** 

General voting was held on November 15, 2008, from 8:00 a.m. to 8:00 p.m. at twenty locations spread throughout Kelowna. This was an increase of four from the number of general voting locations at the 2005 municipal election, and a total increase of ten from the number of general voting locations at the 2002 local government election. Voter turnout was low in five locations, receiving fewer than

500 voters, with the majority of voters spread evenly throughout the city, including eight locations receiving between 500-1000 voters, and six between 1000-1300 voters. The highest voter turnout was once again at the Rutland Senior Secondary School location (1593).

Estimated turnout for the City of Kelowna election this year was 19.6%.

## **Alternative Opportunities for Voting:**

The Local Government Act provided greater flexibility for residents to vote in the 2008 Municipal Election, including mail-in voting opportunities, and advance voting opportunities with no restrictions for eligible electors.

We had several inquiries during this election from City of Kelowna residents, and a resolution from the Advisory Committee for People with Disabilities, with respect to voting opportunities that would ensure both the secrecy and the independence of the vote for people with visual disabilities. Currently, voters may request assistance to mark a ballot from individuals who complete a Declaration of Assistance to an Elector.

The mail-in voting opportunity was an option available for voters with a physical disability, illness or injury that would affect their ability to vote at a regular voting place OR for voters who are going to be out of town on all voting days. The existing legislative requirements however provided a very limited window of opportunity in which to finalize the ballots, receive them, mail, and return by mail, the marked ballots to be counted in the election. Amendments to the *Local Government Act* to enhance this voting opportunity would be beneficial to residents in future elections. Staff will be following up with the Ministry regarding the effectiveness of the recent amendments
