### 1. CALL TO ORDER

Deputy Mayor Reid called the meeting to order at 1:32 p.m.

Councillor Rule was requested to check the minutes of the meeting.

## 3. PUBLIC IN ATTENDANCE

3.1 Peter Rotheisler, Waste Reduction Supervisor, Regional Waste Reduction Office, Regional District of Central Okanagan, re: <u>Automated Collection</u>

Peter Rotheisler, Waste Reduction Supervisor:

- Showed a DVD from a CHBC report on automated collection.
- Gave a presentation to Council regarding the Automated Waste Collection Program.
- Advised that the program will be rolled out to West Kelowna/Peachland in February, Lake Country/Regional District in March and Kelowna in April to June.

### 4. UNFINISHED BUSINESS

4.1 Urban Forestry Supervisor, dated January 27, 2009, re: <u>Feral Rabbit</u> Update

#### Staff:

- Advised that approximately 67 animals have been trapped in the past 2 weeks. Approximately 654 rabbits have been removed since the contract commenced.
- Advised that EBB Environmental Consulting Inc. advised that the cost to extend the contract, based on the numbers of rabbits able to be trapped, is as follows:
  - 150 rabbits = \$5,780.38;
  - 100 rabbits = \$11,560.76; and
  - 150 rabbits = \$17,341.15.
- This Provincial Government has advised that there are certain permits that are required should the Farmer John's Petting Zoo be used. As well, a concern was expressed regarding the relocation of rabbits to a petting zoo and the fact that the rabbits would not be spayed or neutered.

#### Council:

- There is a great deal of concern in the agricultural community regarding the rabbit issue.
- A maintenance program needs to be established in order to deal with the ongoing issue.

- Would be agreeable to placing a Restrictive Covenant on the property in order to limit the scope of the commercial operation on the site.

#### Staff:

- Confirmed that it is difficult to achieve proper fire flows on the site when well water is being used.
- Advised that the applicant would be responsible for the cost of connecting any servicing in the area.
- Advised that the Covenant would only address the "land use" issue and not the "servicing" issue. The "servicing" issue is the issue staff are most concerned with.

#### City Manager:

- Believes that a landscape business would not be considered an "agricultural" use by the Agricultural Land Commission.
