RECOMMENDATION:

THAT Council receive, for information, the Report from the Director, Design & Construction Services dated June 5, 2009 with respect to awarding the contract for the construction of the Glenmore Road Bypass 2 & 3:

AND THAT the Contract for the construction of the Glenmore Road Bypass 2 & 3 – (Dallas Road to Scenic Road) be awarded to Ansell Construction Ltd. for the amount of \$ 7,837,634.18, which includes GST:

AND THAT the Mayor and City Clerk be authorized to execute the Contract;

AND FURTHER THAT the Director, Design & Construction Services be authorized to approve any necessary Change Orders to the Contract up to a maximum amount of \$500,000.

BACKGROUND:

In accordance with the City of Kelowna Official Community Plan (OCP) 2001-2020, the Glenmore Bypass project will follow a new road alignment along a corridor to the east of the existing Glenmore Road. The project consists of the construction of a four lane roadway from Dallas Road to Union Road, reducing to two lanes from Union Road to Scenic Road.

The entire length of the new roadway will be approximately 2.3 kilometres and include a separate 1.9 kilometre multi-use pathway on the west side of the Bypass corridor for bicyclists and pedestrians. New traffic signals will be installed on the Bypass at the intersections of Cross Rd., Union Rd. and Scenic Rd.

The construction work for this contract is anticipated to commence in June 2009 and is expected to be completed by June 30, 2010.

In response to the City's invitation to Tender TE-09-03, Ten (10) bids were received, as tabulated below:

Our Consultant has reviewed the bid submissions, checked the arithmetic accuracy and provided the City with a tender analysis, a list of the corrected bids and a recommendation to award this contract to Ansell Construction Ltd.

Prior to advertising the Invitation to Tender, our Engineering Consultant estimated the construction cost for all the components of the Contract to be \$10,227,688.09 including GST and contingency. There are sufficient funds in the 2009 Budget to cover the costs of the Contract amount plus the Contingency amount.
