Public Hearing June 16, 2009

A Public Hearing of the Municipal Council of the City of Kelowna was held in the Council Chamber, 1435 Water Street, Kelowna, B.C., on Tuesday, June 16<sup>th</sup>, 2009.

- 1. Mayor Shepherd called the Hearing to order at 6:04 p.m.
- 2. Mayor Shepherd advised that the purpose of the Hearing is to consider certain bylaws which, if adopted, will amend "Kelowna 2020 Official Community Plan Bylaw No. 7600" and "Zoning Bylaw No. 8000", and all submissions received, either in writing or verbally, will be taken into consideration when the proposed bylaws are presented for reading at the Regular Council Meeting which follows this Public Hearing.

The City Clerk advised the Notice of this Public Hearing was advertised by being posted on the Notice Board at City Hall on May 29<sup>th</sup>, 2009, and by being placed in the Kelowna Daily Courier issues of June 8<sup>th</sup>, 2009 and June 9<sup>th</sup>, 2009, and in the Kelowna Capital News issue of June 7<sup>th</sup>, 2009, and by sending out or otherwise delivering 376 letters to the owners and occupiers of surrounding properties between May 29<sup>th</sup>, 2009 and June 3<sup>rd</sup>, 2009.

The correspondence and/or petitions received in response to advertising for the applications on tonight's agenda were arranged and circulated to Council in accordance with Council Policy 309.
