Municipalities with a Municipal Police Unit Agreement (MPUA) with the province for the delivery of RCMP services are invited to a meeting to receive an update on the current status of the RCMP contract renewal negotiations and to provide input on the matters that are being negotiated. Kevin Begg, Assistant Deputy Minister, Policing and Community Safety Branch, who is the province's principal negotiator for RCMP contract renewal will be presenting information at the meeting and receiving input. The meeting will be held on Wednesday, January 20, 2010 in Richmond. UBCM requests that each municipality send no more than two representatives to this meeting, such as the Mayor or Council Designate and the Administrator or Chief Financial Officer or Principal Police Contact. A registration form is attached for your use in registering for the meeting. Further information will be provided in advance of the meeting to those who register to attend.

As you are aware, the RCMP contract expires in March 2012 and negotiations are currently underway between the federal and provincial governments to renew the contract. UBCM, which is acting on behalf of municipalities in providing input in the contract renewal process, is providing an opportunity for municipalities with Municipal Police Unit Agreements to get a better sense about what the expected results of the negotiations may be, to provide input into the process and to provide feedback on the matters under consideration. The discussions have moved from the issue identification stage to the contract negotiations stage and it is important to get your input early in this process. The feedback will be used in the ongoing negotiations that are underway.
