

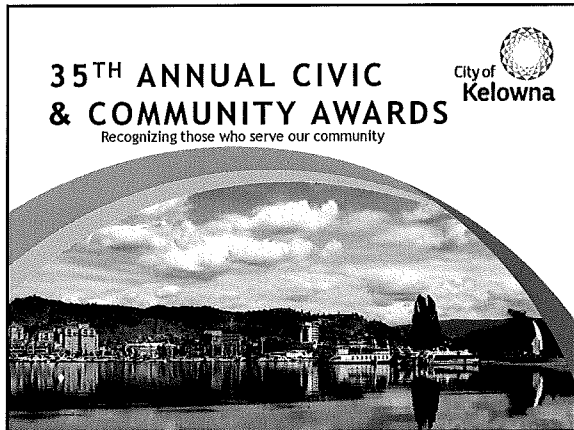

- ▶ Nominees must be between the ages of 13 and 19 as of December 31, 2009



TEEN HONOUR IN THE ARTS AWARD
