

# CITY OF KELOWNA

## BYLAW NO. 10362

### Amendment No. 3 to Recreation, Parks and Cultural Services Fees and Charges Bylaw No. 9609

---

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts that the City of Kelowna Recreation, Parks and Cultural Services Fees and Charges Bylaw No. 9609 be amended as follows:

1. THAT all references that read “All rates are subject to GST unless otherwise stated.” be deleted and replaced with “All rates are subject to taxes unless otherwise stated.”
2. AND THAT **SCHEDULE A, Parkinson Recreation Centre – Facility Admission Fees and Charges** be amended by:
  - a) deleting all references to “(GST Included)” ; and
  - b) deleting “(GST not applicable)” in the Table for **Access Pass Fees** and replacing it with the words “(Tax Exempt)”
3. AND THAT **SCHEDULE B – Parkinson Recreation Centre – Facility Rental Fees and Charges** be amended by:
  - a) deleting the words in the Table “(Rates per hour, not including GST)” and replacing it with “(Rates per hour)”; and
  - b) deleting the words in the Tables “(not including GST)”
4. AND THAT **SCHEDULE C – Apple Bowl – Facility Rental Fees and Charges** be amended by deleting the words “(not including GST)” in its entirety;
5. AND THAT **SCHEDULE D – Sports Fields – Rental Fees and Charges** be amended by:
  - a) adding the sentence “All rates are subject to taxes unless otherwise posted.” above the word “**ADULT:**”; and
  - b) by deleting all references “(not including GST)” in the Tables for **ADULT** and **MINOR**;
6. AND THAT **SCHEDULE E – Arenas – Rental Fees & Charges** be amended by deleting the words “(not including GST)” in the Table **SEASONS** and “(including GST)” in the Table **PUBLIC SKATING**;
7. AND THAT **SCHEDULE F – 2009 Multi-Purpose Facilities – Rental Fees and Charges** Table be amended by deleting the words “(not including GST)”;
8. AND THAT **SCHEDULE G – Other Facilities/Parks – Fees and Charges** Table be amended by deleting the words “(not including GST)”;

9. AND THAT **SCHEDULE H – Kelowna Community Theatre – Fees and Charges** Table be amended by adding the sentence “All rates are subject to taxes unless otherwise posted.” above the Table;
10. This bylaw shall come into full force and effect and be binding on all persons as and from the date of adoption.
11. This bylaw may be cited as “Bylaw No. 10362, being Amendment No. 3 to Recreation, Parks and Cultural Services Fees and Charges Bylaw No. 9609.
