Amendment No. 16 to Traffic Bylaw No. 8120

The Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT SCHEDULE "A" - FEES, <u>PART 5 – HIGHWAY USE REGULATIONS</u>, <u>subsection 5.4.2 – Road Usage Permit</u> of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting in it's entirety and replacing it with the following:

"Subsection 5.4.2 - Road Usage Permit

Duration of Permit

Traffic Impedance 1 day or less 2 days to 7 days 8 days to 30 days More than 30 days Extension Fee Fee

Free \$47.62 \$190.48 \$333.33 \$333.33/month \$38.10

*Plus applicable taxes."

 THAT SCHEDULE "A" - FEES, <u>PART 5 – HIGHWAY USE REGULATIONS</u>, <u>sub-</u> section 5.5.3 – Hoarding Permit Application of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting the following:

"Hoarding occurring for less than 8 hours Hoarding occurring for greater than 8 hours, up to 1 month \$50 \$8m²/month or Portion thereof"

and replacing it with:

"Hoarding occurring for less than 8 hours Hoarding occurring for greater than 8 hours, up to 1 month \$47.62 \$7.62m²/month or Portion thereof";

- THAT SCHEDULE "A" FEES, <u>PART 7 SIDEWALK/ROADWAY OCCUPANCY</u> <u>PERMITS</u>, <u>sub-section 7.1.6 Permit Fee</u> of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting the words "\$100.00 per location per month" for "Portable Food Services Vending Cart or vehicle:" and replacing it with the words "\$100.00 plus applicable taxes per location per month.";
- THAT SCHEDULE "A" FEES, <u>PART 7 SIDEWALK/ROADWAY OCCUPANCY</u> <u>PERMITS</u>, <u>sub-section 7.1.6 Permit Fee</u> of the City of Kelowna "Traffic Bylaw No. 8120" be further amended by adding the words "plus applicable taxes," before the words "per square metre of permit area used for patron seating,";
