BYLAW NO. 10364

Amendment No. 16 to Traffic Bylaw No. 8120

The Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT **SCHEDULE "A" - FEES, PART 5 – HIGHWAY USE REGULATIONS**, sub-section **5.4.2 – Road Usage Permit** of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting in it's entirety and replacing it with the following:

"Subsection 5.4.2 - Road Usage Permit

<u>Duration of Permit</u>	<u>Fee</u>
Traffic Impedance	Free
1 day or less	\$47.62
2 days to 7 days	\$190.48
8 days to 30 days	\$333.33
More than 30 days	\$333.33/month
Extension Fee	\$38.10

*Plus applicable taxes."

2. THAT **SCHEDULE "A" - FEES, PART 5 – HIGHWAY USE REGULATIONS**, sub-section **5.5.3 – Hoarding Permit Application** of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting the following:

"Hoarding occurring for less than 8 hours	\$50
Hoarding occurring for greater than 8 hours, up to 1 month	\$8m ² /month or Portion thereof"

and replacing it with:

"Hoarding occurring for less than 8 hours	\$47.62
Hoarding occurring for greater than 8 hours, up to 1 month	\$7.62m ² /month or Portion thereof";

3. THAT **SCHEDULE "A" - FEES, PART 7 – SIDEWALK/ROADWAY OCCUPANCY PERMITS**, sub-section **7.1.6 Permit Fee** of the City of Kelowna "Traffic Bylaw No. 8120" be amended by deleting the words "\$100.00 per location per month" for "Portable Food Services Vending Cart or **vehicle**:" and replacing it with the words "\$100.00 plus applicable taxes per location per month.";

4. THAT **SCHEDULE "A" - FEES, PART 7 – SIDEWALK/ROADWAY OCCUPANCY PERMITS**, sub-section **7.1.6 Permit Fee** of the City of Kelowna "Traffic Bylaw No. 8120" be further amended by adding the words "plus applicable taxes," before the words "per square metre of permit area used for patron seating,";

5. This bylaw may be cited for all purposes as "Bylaw No. 10364, being Amendment No.16 to City of Kelowna Traffic Bylaw No. 8120."
6. This bylaw shall come into full force and effect and is binding on all persons as and from the date of adoption.
