#### Recommendation:

THAT Council receive the Annual Report for the year ended December 31, 2009.

AND THAT Council receive the Council Remuneration and Expenses report, Employee Remuneration report and schedule of Payment for the Provision of Goods and Services.

#### Purpose:

To meet legislated reporting requirements for annual financial statements and provide contextual information for the data contained in the remuneration reports.

## Background:

In June, the City of Kelowna's annual financial statements for the year ended December 31, 2009 were reviewed by the Audit Committee; these statements were subsequently approved by Council.

In addition to the financial statements, the Annual Report summarizes the City's strategic plan, highlights actions and efforts taken in 2009 to achieve that plan and outlines plans for 2010 that will build upon 2009 and prior year efforts.

A report on permissive tax exemptions granted by Council is included in the annual report. The amount reported in this section is the municipal portion of taxes exempted for the year 2009 as required under the Community Charter. A report is also included on Development Cost Charges to indicate the activity for charges received, expenditures made and any waivers or reductions for each DCC group.

Within the Annual Report, following the Audited Consolidated Statements and Notes to Consolidated Statements, is the Statistical Review, in graphic format for the years 2005 through 2009. All revenue and expenditures have been removed from the annual report because we only have two-year comparisons due to the new tangible capital asset requirements. These statistics will be included in subsequent years.

The statement of Council remuneration and expenses, employee remuneration report, and the schedule of payment for the provision of goods and services are prepared annually as part of the Financial Information Act reporting requirements.

The 2009 employee remuneration report has a number of one-time payments that would not normally be included in a regular year. The most significant impact is the number of firefighters included this year due to a retroactive payment coming from a labour agreement that was two years in the making. Many of the firefighters will now exceed the \$75,000 threshold and be included on future reports.

Overtime payments to firefighters and emergency operations centre (EOC) staff due to the Westside Fires in 2009 also increased the remuneration received by several staff. All EOC work contributed by City staff during regular business hours is not recovered from municipal partners in recognition of the regional nature of the partnership. City staff related overtime for direct EOC work only, is reimbursed to the City by the Provincial Emergency Program.

On the management side, the remuneration comparison is explained by reorganized departmental responsibilities that occurred in the fall of 2008. This reorganization was done to meet the needs of a growing city. Rather than have decision making responsibility rest with a few managers at the top, responsibility was assigned to more people to create a more responsive and results oriented organization. Under the previous organizational structure the number of direct reports to the City Manager was no longer effective or efficient. These financial changes were only partially reflected in 2008 and thus show a greater impact in 2009.

It is difficult to compare one year to the next, as conditions are always changing. However, the change from 153 staff receiving greater than \$75,000 in 2008 to 209 staff in 2009 is mainly due to the above three changes. The chart below provides a summary of the changes by employee group:

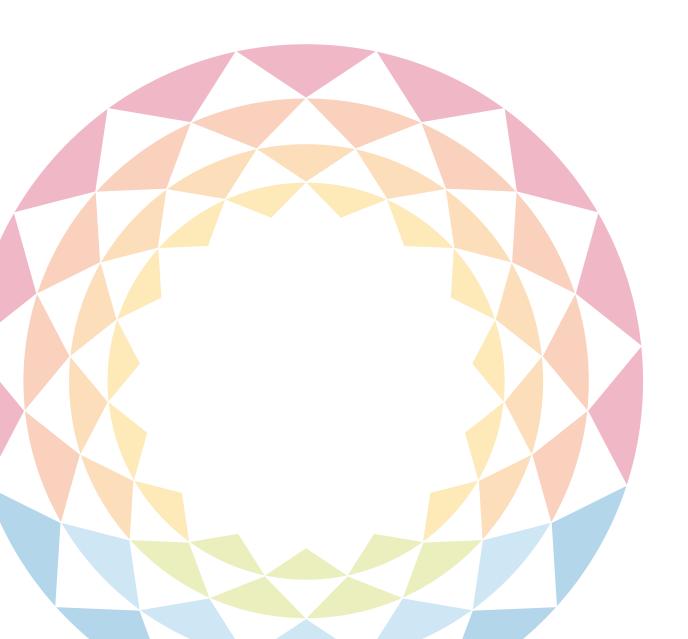
