Public Hearing November 30, 2010

- 1. Deputy Mayor Hodge called the Hearing to order at 6:00 p.m.
- 2. Deputy Mayor Hodge advised that the purpose of the Hearing is to consider certain bylaws which, if adopted, will amend "Kelowna 2020 Official Community Plan Bylaw No. 7600" and "Zoning Bylaw No. 8000", and all submissions received, either in writing or verbally, will be taken into consideration when the proposed bylaws are presented for reading at the Regular Council Meeting which follows this Public Hearing.

The City Clerk advised the Notice of this Public Hearing was advertised by being posted on the Notice Board at City Hall on November 12, 2010, and by being placed in the Kelowna Daily Courier issues of November 22, 2010 and November 23, 2010, and in the Kelowna Capital News issue of November 21, 2010, and by sending out or otherwise delivering 112 letters to the owners and occupiers of surrounding properties between November 12, 2010 and November 19, 2010.

The correspondence and/or petitions received in response to advertising for the applications on tonight's agenda were arranged and circulated to Council in accordance with Council Policy 309.

INDIVIDUAL BYLAW SUBMISSIONS

Bylaw No. 10449 (Z10-0084) - Pargat and Jagjeet Bhander - 447 Sumac Road East - THAT Rezoning Application No. Z10-0084 to amend the City of Kelowna Zoning Bylaw No. 8000, by changing the zoning classification of Lot 49, Section 26, Township 26, ODYD Plan KAP51596, located on Sumac Road East, Kelowna, BC from the RU1 - Large Lot Housing zone to the RU1s - Large Lot Housing with a Secondary Suite zone, be considered by Council;

AND THAT the zone amending bylaw be forwarded to a Public Hearing for further consideration;

AND THAT the suite be eligible for a final occupancy prior to final adoption of the zone;

AND THAT final adoption of the zone amending bylaw be considered subsequent to the discharge of the restrictive covenant;
