Recommendation:

THAT Council consents to the assignment of the Air Terminal Building Sublease dated January 4, 1990, and all amendments and assignments thereto, between the City of Kelowna and Jazz Air LP as set out in Appendix "A" attached to the Report of the Airport Director, dated January 31, 2011;

THAT Council consents to the assignment of the Sublease of the joint-use glycol storage facility dated January 16, 2003, and all amendments and assignments thereto, between the City of Kelowna and Jazz Air LP as set out in Appendix "A" attached to the Report of the Airport Director, dated January 31, 2011;

AND THAT the Mayor and City Clerk be authorized to execute the Consent to Assignment of Sublease documents on behalf of the City.

Purpose:

To obtain Council's consent to the assignment of two Subleases between Jazz Air LP and the City with respect to facilities at Kelowna International Airport.

Background:

In December 1990, Council approved an Air Terminal Building Sublease with Air BC Limited, which subsequently changed its name to Jazz Air LP through a series of assignments.

In January 2003, Council approved a land Sublease for the joint-use glycol facility with Jazz Air Inc., which also changed its name to Jazz Air LP through a series of assignments. Jazz Air LP is one of three air carriers who are signatories to the joint-use glycol facility Sublease.

Jazz Air LP is transferring its assets and operation to Jazz Aviation LP, a new Ontario limited partnership, pursuant to an internal reorganization. Upon completion of the reorganization, the City shall have the right to enforce the Subleases directly against Jazz Aviation LP.



Both of the Subleases contain provisions for such assignments, subject to the written consent of the City.

Dear Sirs/Mesdames:

In connection with the proposed conversion of Jazz from an income fund structure to a corporate structure, Jazz Air LP is also planning to transfer all of its assets to a new Ontario limited partnership Jazz Aviation LP (the "New Jazz LP"), to be represented by its general partner Aviation General Partner Inc., pursuant to an internal reorganization (the "Reorganization"). The business as now owned and conducted by Jazz Air LP is unaffected by the Reorganization, other than that after the Reorganization the business will be owned and conducted by the New Jazz LP. In connection with the Reorganization, New Jazz LP shall assume all of the obligations and liabilities of Jazz Air LP under the Contract and the New Jazz LP will own substantially all of the assets of Jazz Air LP.

We hereby request the consent of the City, in advance, to the Reorganization, by execution and delivery of this letter, which shall constitute your consent to the assignment of the Contract and the transfer of all or substantially all of the assets of Jazz Air LP in connection with the Reorganization (the "Consent").

The requested Consent shall constitute your consent and agreement that following the completion of the Reorganization, Jazz Aviation LP shall be a party to the Contract and on completion of the Reorganization, the City shall have the right to enforce the Contract directly against Jazz Aviation LP.
