## **BYLAW NO. 10510**

## Text Amendment No. TA11-0001 – Miscellaneous Housekeeping Text Amendments to the City of Kelowna Zoning Bylaw No. 8000

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts that City of Kelowna Zoning Bylaw No. 8000 be amended as follows:

- 1. THAT **Section 9 Specific Use Regulations, 9.5 Secondary Suite**, sub-section 9.5.8 be deleted in its entirety and replaced with the following:
  - "9.5.8 In all urban and rural residential zones, a secondary **dwelling** unit is not permitted in conjunction with lodgers, bed and breakfast accommodation or a group home."
- 2. AND THAT **Section 9 Specific Use Regulations, 9.5 Secondary Suite** be amended by adding a new sub-section 9.5.13 as follows:
  - "9.5.13 A pathway is required from the on-site **secondary suite** parking stall(s) to the suite entrance."
- 3. AND THAT Section 11 Agricultural Zones/11.1 A1 Agriculture1/A1s Agriculture 1 with Secondary Suite/A1t Agricultural 1 with Agri-tourist Accommodation, subsection 11.1.7 Other Regulations be amended by adding in a new sub-paragraph (j) in its appropriate location:
  - "11.1.7 j) **Bed and breakfast homes or group homes, minor** in combination with a **secondary suite** shall not be located on parcels less than 2.0 ha in size."
- 4. AND THAT Section 14 Commercial Zones/C4-Urban Centre Commercial/C4rls-Urban Centre Commercial (Retail Liquor Sales)/C4lp Urban Centre Commercial (Liquor Primary)/C4lp/rls-Urban Centre Commercial (Liquor Primary/Retail Liquor Sales), subsection 14.4.2 Principal Uses be amended by deleting sub-paragraph "(f) breweries and distilleries, major" in its entirety and renumbering all sub-sequent sub-paragraphs.
- 5. AND FURTHER THAT Section 14 Commercial Zones/C7-Central Business Commercial/C7rls Central Business Commercial (Retail Liquor Sales)/C7lp Central Business Commercial (Liquor Primary)/C7lp/rls Central Business Commercial (Liquor Primary/Retail Liquor Sales), sub-section 14.7.2 Principal Uses be amended by adding in it's appropriate location a new sub-paragraph "breweries and distilleries, minor" and renumbering all sub-sequent sub-paragraphs.
- 6. This bylaw shall come into full force and effect and is binding on all persons as and from the date of adoption.
