THAT Council receives, for information, a report from the Director of Infrastructure Planning dated April 26, 2011, with respect to the City Wide Water Supply and Treatment Improvement Memorandum of Understanding with the Kelowna Joint Water Committee (KJWC) dated August 18, 2010.

AND THAT, Council approves the addition of Addendum #1 to the Memorandum of Understanding between the City of Kelowna and the Kelowna Joint Water Committee (KJWC) and authorizes the Mayor and City Clerk to execute Addendum #1 for an extension of 6 months to the original terms of the agreement, with mutual consent of all signatories.

Purpose:

To extend the term of the MOU so that the Kelowna Joint Water Committee (KJWC) can complete its work.

Background:

On September 15, 2010, Council executed the City Wide Water Supply and Treatment Improvement Memorandum of Understanding ("MOU"), with the members of the Kelowna Joint Water Committee including the following term:

"This MOU shall be in force for the period of 8 months following the date of the execution provided the parties may by mutual consent extend the agreement."

The parties have worked with diligence to complete the requirements of the Memorandum of Understanding. However, the parties require additional time to complete the work. Addendum #1 extends the term of the MOU for an additional 6 months.
