Parkland Acquisition Guidelines

### Recommendation:

THAT Council receives, for information, the report from the Director, Infrastructure Planning dated June 6, 2011 with respect to the 2011 Planning Institute of British Columbia Award of Excellence for the City of Kelowna's Parkland Acquisition Guidelines.

### Purpose:

To present an award recognizing the City of Kelowna to Mayor and Council.

### Background:

The Planning Institute of BC (PIBC), at its annual conference in Nanaimo on June 2, 2011, conferred an Award of Excellence, Honourable Mention, on the City of Kelowna for "Excellence in Planning Practices" for its "Parkland Acquisition Guidelines." The criteria for the award are provided in their website (see <a href="https://www.pibc.bc.ca/content/awards-categories-criteria">www.pibc.bc.ca/content/awards-categories-criteria</a>) follows:

"Excellence in Planning Practice: This category recognizes the efforts of planners to turn policy into reality, whether it is taking design guidelines to craft a new urban space or using community partnerships to secure funding for much needed projects. This category may also recognize the written and published documents and audio-visual materials intended to fully engage the public in worthwhile planning programs and projects. It also recognizes new directions for the profession and may include innovative project management or planning processes. This is the category where the rubber meets the road. How did you create that fascinating mixed-use development or how did you tell the story in the multi-ethnic neighbourhood so all could understand?"

In the fall of 2009 Infrastructure Planning engaged the firm of Juliet Anderton Consulting Inc. to help staff from various city departments, (including Finance, Recreation & Culture, Land Use Management, Civic Operations, Development Services, Real Estate and Building Services, Policy and Planning, and the Fire Department), prepare a reference document that describes, both in text and graphics, criteria currently followed in the selection of new parkland in both developing neighbourhoods and mature areas of Kelowna, and best management practices in terms of park site servicing requirements. Information contained in these guidelines is easily transferable and could be tailored to meet the needs of other communities in British Columbia. Ms. Anderton was also named in the award.

On January 24, 2011 City Council endorsed the Parkland Acquisition Guidelines as part of Council Policy No. 303.
