



- Climate Action Plan consultation completed

DIVERSE, SUSTAINABLE INFRASTRUCTURE Downtown Plan Charrette

- 25-year vision to become basis for updated Downtown Plan
- New ideas for building heights and city investments
- 41 stakeholder participants and 335 at Open Houses



Bernard Avenue Revitalization

- Preliminary design phase concluded with Downtown Kelowna Association support to begin petition process
- \$11 million rebuild of utilities, roadbed and streetscape from Sails to Richter





DIVERSE, SUSTAINABLE INFRASTRUCTURE

- Airport Way Multi-Use Corridor
 - two-km long corridor, two-lane roadway
 - 81 stall parking lot, sidewalk decorative street lighting
 - Project Value is \$4.3 million
- Preliminary design for a 1.5-km pathway linking trails in Rutland to UBC-O.
 - Partnered with Province and UBC-Okanagan

Lawson Lane wastewater Project value: \$250,000



A GROWING PROGRESSIVE ECONOMY Kelowna International Airport

- Runway overlay tender pricing came in significantly above budget; work deferred to 2012.
- 800 attended Spring to Europe event
- Airport Watch program has grown to 30 volunteers and two volunteer coordinators
