# CHAIRPERSON WILL CALL THE HEARING TO ORDER:

- 1. (a) The purpose of this Hearing is to consider an application for a block exclusion of land from an Agricultural Land Reserve (ALR) under Section 29(1) of the Agricultural Land Commission Act
  - (b) All persons who believe that their interest in property is affected by the proposed application shall be afforded a reasonable opportunity to be heard or to present written submissions respecting matters contained in the application that are the subject of this hearing.
  - (c) All information, correspondence, petitions or reports that have been received concerning the subject application have been made available to the public. The correspondence and petitions received after July 22, 2011 (date of notification) are available for inspection during the course of this hearing and are located on the information table in the foyer of the Council Chamber.
  - (d) All representations to Council form part of the public record and a live audio feed is being broadcast and recorded by CastaNet.
  - (e) Council may, without further notice, allow amendment to the proposed application to give such effect as it considers fit to accommodate representations made at the hearing.

- (f) It must be emphasized that Council will not receive any representation from the applicant or members of the public after conclusion of this Public Hearing.

#### 4. PROCEDURE ON EACH APPLICATION:

- (a) Brief description of the application by City Staff (Land Use Management).
- (b) The Chairman will request that the City Clerk indicate all information, correspondence, petitions or reports received for the record.
- (c) The applicant is requested to make representation to Council regarding the project and is encouraged to limit their presentation to 15 minutes.
- (d) The Chairman will call for representation from the public in attendance.
  - (i) The microphone at the podium has been provided for any person(s) wishing to make representation to the meeting.
  - (ii) The Chair will recognize **ONLY** speakers at podium.
  - (iii) Speakers are encouraged to limit their remarks to 5 minutes. However, if they have additional information they may address Council again after all other members of the public have been heard a first time.

- (e) Once the public has had an opportunity to comment, the applicant is given an opportunity to respond to any questions raised. The applicant is requested to keep the response to a total of 10 minutes maximum.
- (f) Questions of staff by members of Council must be asked before the Public Hearing is closed and not during debate of the application at the Regular Meeting, unless for clarification.
- (g) Final calls for representation (Ask three times). Unless Council directs that the public hearing on the application in question be adjourned (held open), the chairman shall state to the gallery that the public hearing on that application is closed.

Note: Any applicant or member of the public may use visual aids (eg. photographs, sketches, slideshows, etc.) to assist in their presentation or questions. The computer station and ELMO document camera at the public podium are available. Please ask staff for assistance prior to your item if required.
