#### RECOMMENDATION:

THAT Council receives, for information, the Report from the Policy & Planning Department dated August 17, 2011 with respect to the staff and budget implications of the Community Wildfire Protection Plan.

#### **PURPOSE:**

To provide Council with the approximate cost, in dollars and personnel hours, for undertaking each of the eight 'Priority A' recommendations that are not currently being undertaken, in relation to wildfire preparedness.

This report is in response to Service Request 195997:

COUNCIL RESOLUTION FROM THE MAY 16, 2011 P.M. REGULAR MEETING: THAT Council receives, for information, the Report from the Policy & Planning Department dated May 11, 2011, with respect to the Community Wildfire Protection Plan (CWPP); AND THAT Council directs staff to report back on staff and budget implications of the CWPP recommendations pertaining to initiatives not currently being undertaken.

#### **BACKGROUND:**

In 2004, the City of Kelowna undertook a review of lands within the city to assess the risk of wildfire, the subsequent threat to structures and natural features, as well as fire suppression constraints. The outcome from that review was the Community Wildfire Protection Plan (CWPP).

It is generally accepted that the CWPP and the information used to develop the document is only valid for a five year period to remain current with changes in forest cover, new developments within interface areas, areas that have received treatment, etc.

The City received funding through a UBCM grant to assist with updating of the CWPP.

The <u>CWPP report</u> provides key recommendations which have been prioritized for implementation within the next 20 years. Priority A items are recommended for implementation within the short-term (1 - 5 years), Priority B within the mid-term (6-10 years) and Priority C within the long-term (10-20 years). Since it is commonly accepted that a CWPP should be updated every five years, this report only highlights the 'Priority A' recommendations.

The City is currently actively responding to the following 'Priority A' recommendations that were outlined in the CWPP report as part of regular ongoing mitigation:

Rec # 6	Treat all City owned interface polygons that were identified as posing a risk of moderate or greater		
Rec # 8	All fuel treatments carried out in the wildland/urban interface should follow a "Fuel Treatment Prescription" developed and submitted to the City by a Professional Forester		
Rec # 9	Monitor the pine beetles and be proactive to remove all dead and dying pine in the urban/wildland interface		
Rec # 13	Basic suppression equipment should be kept in strategic locations around the City		
Rec # 18	Ensure that grass is maintained and that all tree cutting is cleaned up adequately along roadways		
Rec # 19	Ensure all roads constructed in interface areas meet standards required for suppression vehicles		
Rec # 32	The FireSmart guidelines should be considered as the minimum standard any new development proposed within the Wildland Fire Hazard Development Permit Areas must adhere to		
Rec # 37	Summaries of this report and associated maps should be posted at strategic public locations		
Rec # 39	A representative from the District Parks Department and the Fire Department should be present at public events that take place in or near natural areas		

Attachment 1 contains the 'Priority A' recommendations from the CWPP report that the City is not currently undertaking but which are recommended for completion within the next five years. The recommendations are divided into three tables. The first table (Rec #35, Rec #36) contains recommendations which will be undertaken as part of a previous Council Resolution (R098/11/01/31).

## Moved by Councillor Blanleil/Seconded by Councillor Hobson

R098/11/01/31 THAT Council directs Policy & Planning Department staff to bring forward, as part of the Official Community Plan review process currently underway, Official Community Plan amendments that would require Wildfire Development Permits only at subdivision;

AND THAT Council directs Development Services Department staff to implement a process whereby wildfire hazard information is provided to applicants building in wildfire hazard areas, prior to issuance of a building permit;

AND FURTHER THAT Council directs the Development Services Department, Fire Department and Civic Operations Department to work together to identify, for 2012 budget consideration, a pro-active and cost effective way to provide ongoing awareness-raising and monitoring/enforcement of covenants and Development Permit provisions.

The second table (Rec #34, Rec #41, Rec #38, Rec #7, Rec #44) in Attachment 1 are the recommendations which are not currently being undertaken by the City, and are also recommended by Staff to pursue. The recommendation in table three (Rec #16) has been deemed unnecessary because currently there are no forest licensees working within the City boundary and therefore the City is not impacted by this action. Attachment 1 also contains the approximate cost, in dollars as well as personnel hours, to undertake each of the recommendations, the department which will be responsible for overseeing each, as well as the budget year in which each recommendation will be undertaken.

In addition to providing recommendations, the CWPP updated fire hazard mapping to reflect new development and forest conditions in interface areas. The updated mapping has been reflected in the revised Wildland Fire Hazard Development Permit Area map, which is now part of the 2030 Official Community Plan.
