Recommendation:

THAT Council receive for information the report from the City Clerk dated October 25, 2011 pertaining to the Certificate of Sufficiency regarding the City of Kelowna borrowing from the Municipal Finance Authority for the sum of Four Million Dollars (\$4, 000, 000.00);

AND THAT Bylaw No. 10582 being the Loan Authorization Bylaw for the Electrical System Upgrades be forwarded for adoption.

Purpose:

Under Section 86(8) of the Community Charter, the Corporate Officer is to determine and certify whether elector approval has been obtained. The decision of the Corporate Officer is final and conclusive.

Background:

An alternative approval process (AAP) opportunity was open to all electors within the City of Kelowna pertaining to the City of Kelowna borrowing from the Municipal Finance Authority for the sum of Four Million Dollars (\$4, 000, 000.00) by proceeding with the adoption of Bylaw No. 10582 being the Loan Authorization Bylaw for the Electrical System Upgrades. The deadline for receipt of elector responses in the form approved by Council was 4:00 p.m. on Monday, October 24, 2011.

As of the deadline date, the Office of the City Clerk had received 2 valid and 2 invalid signatures. The invalid signatures were submitted on a form not approved by Council.

As insufficient signatures against this Alternative Approval Process were received by the Office of the City Clerk prior to the deadline, Council may proceed with borrowing from the Municipal Finance Authority for the sum of Three Million Dollars through the adoption of Bylaw No. 10582 being the Loan Authorization Bylaw for the Electrical System Upgrades.

LEGAL/STATUTORY AUTHORITY: Community Charter, Sections 86, 94, 174 and 179.

LEGAL/STATUTORY PROCEDURAL REQUIREMENTS:

Under the *Community Charter*, advertisements must be placed in a local newspaper and on a public notice board. Notice of the Alternative Approval Process was advertised in the Kelowna Daily Courier and the Kelowna Capital News on Friday, September 16 and Friday, September 23, 2011 and was posted on the notice board at City Hall on Tuesday, September 3, 2011.
