BYLAW NO. 10468

Amendment No. 17 to "Sign Bylaw No. 8235"

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

- 1. THAT the City of Kelowna, Sign Bylaw No. 8235, SECTION 6 SPECIFIC ZONE REGULATIONS, sub-section 6.1, be amended by:
 - (a) deleting "Higher Density Residential Zones (RM1, RM2, RM3, RM4, RM5, RM6, and RM7)*" and replacing it with Higher Density Residential Zones (RM1, RM2, RM3, RM4, RM5, RM6, RM7, CD22 Sub Areas C, D, E, F, G, H)*";
 - (b) deleting "Major Commercial (C3, C4, C6, C7 and C8)*" and replacing it with "Major Commercial (C3, C4, C6, C7, C8 and CD22 Sub Areas A&B)*"; and
 - (c) deleting under the heading "Major Commercial (C3, C4, C6, C7 and C8)*" the following:

Free-standing	1 per building frontage, except for a flanking lot over 45 m long which may have 1 on each frontage, except a lot may have 1 additional for every additional 150 m frontage over 150 m to a maximum of 4 signs	(a) (b)	8.0 m maximum height except that it is 3.0 m for a site less than 30 m in width or a site in an urban town centre not fronting on Highway 33 or 97 the maximum area is 3.0 m ² per lineal metre of street frontage the sign is located on, up to a maximum 12 m ² for lots smaller than 1000 m ² or on any site in an urban town centre not fronting Highway 33 or 97, 15 m ² for lots greater than 1000 m ² but smaller than 4000 m ² , and

And replace it with:

	maximum of 4 signs. Not Permitted in CD22.	(b) the maximum area is 3.0 m ² per lineal metre of street frontage the sign is located on, up to a maximum 12 m ² for lots smaller than 1000 m ² or on any site in an urban town centre not fronting Highway 33 or 97, 15 m ² for lots greater than 1000 m ² but smaller than 4000 m ² , and 18 m ² for lots greater than 4000 m ²
		(c) the maximum area may be increased by up to 10% if this additional sign area is used for a changeable copy sign

- (d) deleting "Public and Institutional Zones (P1, P2, P3, P4, W1, and W2)*" and replacing it with "Public and Institutional Zones (P1, P2, P3, P4, W1, W2 and CD22 Sub-Area I)*"
- 2. This bylaw may be cited as "Bylaw No. 10468, being Amendment No. 17 to the Sign Bylaw No. 8235".
