## BYLAW NO. 10658

### Amendment No. 29 to City of Kelowna Electricity Regulation Bylaw No. 7639

---

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts as follows:

1. THAT City of Kelowna Electricity Regulation Bylaw No. 7639, SCHEDULE C, CITY OF KELOWNA ELECTRICAL UTILITY BILLING RATES & STREET LIGHTING, MISCELLANEOUS & CONNECTION CHARGES, be amended by deleting Appendices C-1, C-2, C-10, C-11 and C-12 in their entirety and replacing them with new Appendices C-1, C-2, C-10, C-11 and C-12, as attached to and forming part of this bylaw;
2. This bylaw will come into full force and be binding on all persons on the date of adoption.
3. This bylaw may be cited for all purposes as "Bylaw No. 10658 being Amendment No. 29 to City of Kelowna Electricity Regulation Bylaw No. 7639".
