### Recommendation:

THAT Council receives, for information, the report from the Utilities Planning Manger dated March 19, 2012, with respect to 2012 Budget Amendment - Sanitary Sewer Upgrade Airport Way.

AND THAT Council approves \$400,000 (\$123,897 from DCC Sector A, and \$276,103 from Sanitary Utility reserves) for the purposes of constructing a Sanitary Trunk main within Airport Way.

AND FURTHER THAT the 2012 Financial Plan be amended accordingly.

### Purpose:

To allocate funds to the 2012 budget in order to complete necessary sewer upgrades along Airport Way prior to undertaking paving and sidewalk improvements.

### Background:

The Kelowna International Airport has an approved budget to make improvements along Airport Way in order to improve pedestrian safety, from Convair Place to the entrance of the Kelowna International Airport.

During the review of this project, it was determined that the size of the Sanitary Sewer main within this portion of Airport Way was not adequate to accommodate the new expansions proposed within the Airport 2025 Master Plan.

By upgrading the existing sewer now, the City will be able to save substantial costs in the future that would otherwise be required to remove and replace portions of the newly installed pavement and sidewalks scheduled to be installed in 2012.


