

Corporate Greenhouse Gases




- 2011 emissions were reduced to 2007 levels, despite adding building and fleet inventory during this time

- > \$253,000 to create a sustainable infrastructure plan







- Design guidelines encourage pedestrianfriendly development in the downtown




Community Climate Change Action Plan

- \$520,000 in grant funding provided to 39 local non-profit arts, culture and heritage organizations
- > \$130,000 awarded from Canadian Heritage to upgrade the sound systems at the Kelowna Community Theatre
- 101,000 attended 227 performance nights at the Theatre in 2011


