1.0 Recommendation

THAT Council consider the Public Consultation process undertaken by the applicant as outlined in the report of the Land Use Management, dated April 27, 2012 as appropriate for the purpose of Section 879 of the Local Government Act.

AND THAT the OCP and Zone Amending Bylaws be forwarded to a Public Hearing for further consideration:

2.0 Purpose

This application seeks to rezone the subject property from the RU6 - Two Dwelling Housing zone to the RM1 - Four Dwelling Housing zone to legalize an existing four-plex. The proposed zoning requires an amendment to the existing OCP future land use designation. When the OCP amending Bylaw was given initial consideration at the February 6th, 2012 Regular Council meeting the following condition needed to be satisfied prior to forwarding the application to a Public Hearing:

THAT the applicant be required to hold a public information meeting, prior to the bylaws receiving first reading, in accordance with the *Local Government Act* and the City of Kelowna's Development Application Procedures Bylaw No. 10540;

Based on the scale of the proposed development a full public information meeting was not held, the applicant did consult with the abutting neighbours and a few other properties in the neighbourhood. A total of seven properties were consulted and supported the OCP amendment. The applicant has indicated that it was difficult to make contact with the immediate neighbour located at 363 Fizet Avenue but the information was left for their consideration.




