## **BYLAW NO. 10725**

### **Road Closure and Removal of Highway Dedication Bylaw (Portion of Road South of Doyle Avenue between Ellis Street and St. Paul Street)**

**A bylaw pursuant to Section 40 of the Community Charter  
to authorize the City to permanently close and remove the  
highway dedication of a portion of Road South of Doyle  
Avenue between Ellis Street and St. Paul Street**

NOW THEREFORE, the Municipal Council of the City of Kelowna, in open meeting assembled, hereby enacts as follows:

1. That portion of highway attached as Schedule "A" comprising 238.3 m<sup>2</sup> shown in bold black as Road To Be Closed on the Reference Plan #EPP21498 prepared by Neil Denby, B.C.L.S. and completed on 12<sup>th</sup> day of June, 2012, is hereby stopped up and closed to traffic and the highway dedication removed.
2. The Mayor and City Clerk of the City of Kelowna are hereby authorized to execute such conveyances, titles, survey plans, forms and other documents on behalf of the said City as may be necessary for the purposes aforesaid.

Read a first, second and third time by the Municipal Council this 9<sup>th</sup> day of July, 2012.
