Amendment No. 16 to Business Licence and Regulation Bylaw No. 7878

The Municipal Council of the City of Kelowna, in open meeting assembled, enacts that the City of Kelowna Business Licence and Regulation Bylaw No. 7878 be amended as follows:

1. THAT SCHEDULE "A", BUSINESS LICENCING BYLAW NO. 7878, <u>BUSINESS</u> <u>CATEGORIES, LICENCE PERIODS AND FEES PAYABLE</u>, <u>ROOMS FOR RENT</u>, be amended by deleting the following:

7310	Apartment	\$8.37 for each suite with a minimum fee of \$28.43 for each twelve (12) month licence period plus \$23.35 inspection fee for a new licence.
7312	Suite In Residence	\$8.37 for each suite with a minimum fee of \$28.43 for

7315	Bed and Breakfast	\$28.43 for each twelve (12) month licence period plus \$23.35 inspection fee for a new licence.
7320	Apartment, owned and operated by non- profit societies providing rooms for rent for senior citizens and/or low income families	\$1.36 for each suite with a minimum fee of \$28.43 for each twelve (12) month licence period plus \$23.35 inspection fee for a new licence.
7325	Rooming house, private nursing home and rest home	\$5.03 for each room with a minimum fee of \$28.43 for each twelve (12) month licence period plus \$23.35 inspection fee for a new licence.

and replacing it with:

7310	Apartment	\$8.37 for each suite with a minimum fee of \$27.50 for each twelve (12) month licence period.

7325	Rooming house, private nursing home and rest home	\$5.03 for each room with a minimum fee of \$27.50 for each twelve (12) month licence period.

- 3. This bylaw shall come into full force and effect and be binding on all persons as and from the date of adoption.
